<u>School Absences-</u> Bug fix with absence date range is fixed

<u>Phase 2 Grad Points</u> (several fixes and enhancements added over the last few months of releases. All will be explained in the Grad points training, but here are few large one to mention today)

- -On the Student Exemptions / Requirements screen, the following exemptions are now read-only: Economics and Financial Literacy, Fine Arts, and Physical Education. <u>Grad Points now uses the values from the FN-Graduate tab.</u> Depending on your districts access granted to users, it is going to need to be a team effort to get these values checked and make Grad Points look correct. Also keep in mind Profile Bulk Update can be used to update these fields.
- -A nightly calculation is ran to calculate everyone's grad points and/or the click the 'Check for Updated Information button'
- -2017 Requirements tab now displays for students who are graduating in 2017 -JVS tab for districts that have District Trusts setup
- -New Graduation Points Search page

<u>Civil Rights</u> Both Part 1 and Part 2 are now available to run. Part 1 came out in early March, if you ran it and uploaded before the 16.3.4 release came out very late March, the 16.3.4 release included bug fixes that we suggest you re-run your Part 1 and fix in the CRDC website. Be sure read the instructions in the Help Documentation. Especially if you are doing the .csv export as the instructions include how to change your IRN to your NCES code.

Medicaid Roster-District Roster for Medicaid Billing

(Management>Import/Export>District Roster for Medicaid Billing) in the 16.3.4 release now moved this report into the Special Services product. The vendors are now requesting more data on these students which is better populated from the SPS program. The link will not be removed from DASL because there are districts in Ohio that do not use SPS so they will still use DASL.

*Also this is not to be confused with the MER (Medicaid Eligibility Rate) report which will still be ran in DASL.

Mobile App- Discipline

In December Phase 2 of the Mobile App was released to include Discipline. You can now view a student's discipline incidents or add new incidents via the Mobile App <u>if</u> you have appropriate discipline access in Student Information. HB410- Truancy Change-

<u>This handout</u> summarizes the proposed changes for truancy reporting and House Bill 410. We are still awaiting confirmation on what will be required for ODE reporting. Once confirmed Software Answers will work on <u>if</u> any changes will need to be made to the Student Information application.

A second bill that has come across our desks is proposed changes to Senate Bill 82. Here is a link of the proposed changes.
