# New! NEOnet scheduling service!

- \$2.00 per student
- Can be per building
- District must provide master schedule (paper, excel, other electronic formats), but NEOnet will enter all changes and additions up until the end of the current school year. Any master schedule changes made after the schedule is finalized will still be completed by the district.
- NEOnet can assist with mass entering requests and team request scenarios.
   NEOnet will run either run the batch scheduler, or add via course group assignment. Will clean up any errors and try to achieve a high scheduling percentage.

# 2nd semester tips- pages 10-11

o **Schedule changes**- <u>See attached document on tips for making 2nd semester schedule changes.</u>

## Homeroom changes

-If need be, reminder to bulk assign 2nd semester.

-If by class period, remember schedule changes that may have occurred. Can bulk remove, start over and bulk re-assign. Or remember to hand change homeroom if student schedule has changed

#### Snow days

-Reminder if you have a snow day that lands on the first day of your second semester, contact NEOnet to ensure the process is done correctly

-Reminder for any snow day, pre-entered absences must be removed before you mark the day as a snow/calamity day.

# House Bill 166- Medical Excuse pages 12-15

- O Reminder to create an absence type and categorize it as Is Excused and Medical group
- O Reminder that the FS Attendance tab shows all the excused hours. It does not subtract medical hours.
- O Reminder that report cards will print all hours a student has missed. It will not subtract medical hours.

- O **Student Absence Intervention page**: The excessive absences area shows Excused Absences-Medical Excused+Unexcused. A new area will show a total of Medical Excused absences. The consecutive hours section is removed.

## Level 2 FTE Adjustments- Filter for the result code 'Disability no IEP'

Have a disability condition but no matching IEP
